I want to make it so that when "Categoria 1" is selected, then the UISwitch is in the position of the 2nd row and when "Categoria 2" is selected, the switch goes to the position of the 1st row. I will add 2 images to the UITableViewCells. Is it possible to do with a coding or only in the storyboard? A: If you're presenting this UISwitch in a UITableViewCell, it's pretty easy: Instead of writing switch.frame = CGRectMake(0, UISwitch.frame.size.height + UISwitch.frame.origin.y, UISwitch.frame.size.width, UISwitch.frame.size.height); just write switch.frame = CGRectMake(0, UIView.appearance.frame.size.height + UISwitch.frame.origin.y, UISwitch.frame.size.width, UISwitch.frame.size.height); This will place the switch at the same position as the UITableViewCell. You can also choose to add constraints to the UISwitch. If you do that, you can make sure the switch is as far to the top as possible. ## What's New in the Adobe Photoshop 2021?

This testimony, the Plaintiffs assert, could lead a reasonable jury to conclude that the officers' use of force was not reasonable and that Lt. Zook knowingly and intentionally used excessive force. However, this testimony does not give rise to a finding of a constitutional violation because Lt. Zook's actions were objectively reasonable and because probable cause supported the seizure. An officer is entitled to qualified immunity if he reasonably, albeit mistakenly, believes that his use of force is lawful. See *Hoblock v. Alvanos*, 382 F.3d 1243, 1250 (11th Cir.2004). Although Lt. Zook admitted that he knew, prior to the encounter, that someone in a van had fired a shotgun at his marked police cruiser, the uncontradicted evidence supports the conclusion that a reasonable officer in Lt. Zook's position would have believed that his actions, which included removing a shotgun from his police cruiser, were lawful. As Lt. Zook explained at the hearing on the motion for summary judgment, he removed the shotgun from his car because he was going to retrieve the shotgun from between his legs so that it would not be fired. Moreover, Lt. Zook's decision to remove the shotgun from his cruiser and then to use it, even in an attempt to apprehend the Plaintiffs, was reasonable. Lt. Zook feared that any use of his shotgun would make him a potential target. In that situation, a reasonable officer would not allow himself to become a target. Cf. *Harrell v. Florida*, 610 F.3d 1268, 1276 (11th Cir.2010) (holding that an officer is not immune from liability under the Fourth Amendment merely because he or she suspects another of committing a crime; "immunity would be meaningless if police officers were to use such a standard to shield the \*1311 grave human errors that their jobs often require them to make"). Additionally, Lt. Zook's actions were objectively reasonable because probable cause existed. The Plaintiffs suggest that the information available to Lt. Zook at the time he seized the shotgun was insufficient to support a finding of probable cause. However, according to Lt. Zook, the information obtained by Lt. Piercy at the time the van was stopped by Officer Cox included: (1) that the van was seen traveling slowly and erratically, (2) that two shotgun shells were found inside the van's console, (3) that a shotgun was found under the hood of the van, (4) that
