Replacement of the aortic valve: the Stanford technique. Replacement of the aortic valve is performed at most centers, although patient selection criteria remain controversial. The Stanford technique makes valve selection more individualized, minimizing some of the controversy surrounding this type of surgery. This system uses a grading system based on morphologic findings from an echocardiographic evaluation. Patients are considered for valve replacement based on their clinical characteristics and preoperative status. The system allows patients with significant aortic stenosis to be spared aortic valve replacement if they are well treated medically, whereas patients with aortic insufficiency are selected for aortic valve replacement if they have severe symptoms and/or signs or evidence of heart failure. The Stanford system has allowed the selection of patients for aortic valve replacement without increasing the perioperative morbidity. The system also has allowed aortic valve replacement to be performed in situations in which it was contraindicated previously.

A federal district court has ruled that the I.R.S. is not immune from a lawsuit brought by more than 1,000 taxpayers in California who say the agency wrongly helped to trigger a major financial crisis by miscalculating the value of mortgage-backed securities. The case, which has been going on since 2005, is being closely watched by the Obama administration as it tries to get rid of a court order lifting the statute of limitations for civil actions against the agency, making it harder to bring lawsuits like the one settled in this case. It is one of the latest in a series of cases brought in recent years against the I.R.S. by individuals who say they were injured by the agency's failure to collect billions in tax money owed to the government. In their lawsuit, which was filed in 2005, the taxpayers claim that the I.R.S. failed to accurately calculate the value of mortgage-backed securities — which were created to make up a huge portion of the new, more profitable mortgages that the I.R.S. had to accept — and used that calculation to avoid getting paid as much in taxes as it would have if it had valued the securities correctly. The failure, the lawsuit alleges, allowed the agency to avoid billions of dollars in revenue. "The I.R.S. policy of tolerating this kind of miscalculation created the gap," said one of the lawyers who represents the taxpayers, the California law firm of Jay Helget. "They can be sued for that," he said. The decision by Judge Terry J. Hatter Jr. of Federal District Court in Los Angeles comes at a time when the I.R.S. is pressing to have a judge lift an order in the case that "tolled" the statute of limitations.
